## What are Cookies

Cookies are small text files that websites store on your browser or device.

While cookies may not always directly identify you, they can remember your preferences, device, and browser settings and be used to enhance the personalized browsing experience on the Internet.

# **Types of Cookies**

Depending on the period of expiry, cookies may be either session or persistent:

- a session cookie will expire at the end of the user session when the web browser is closed;
- a persistent cookie is stored by a web browser and remains valid until its set expiration date (unless deleted by the user before).

Depending on the provider, there are two types of cookies:

- first-party cookies are placed on websites by hosts of domains;
- third-party cookies are placed on websites by domains other than the one the user is visiting.
   We may not provide all the features necessary to ensure a personalized and convenient user experience, therefore third-party cookies are employed.

Please note that this Policy DOES NOT cover the cookies provided by third parties when you follow the links to any website other than ours.

Depending on the purpose, there are four main types of cookies:

- Necessary (or essential) cookies: enable users to use the Website and Service by providing basic functions, e.g., ensuring security. The Website and Service cannot function properly without these cookies;
- Analytical (or statistics/performance) cookies: collect information about how users interact
  with the Website and Service (e.g., page visits and page load speed). We use them to locate
  and analyze issues or errors that you may encounter, thus enhancing Website and Service
  functionality;
- Marketing (or targeting) cookies: are used to track the visitor's interest in a particular product, measure the number of unique visits, recognize returning users, and deliver a targeted advertisement to users:
- Preferential (or functionality) cookies: enable the Website and Service to remember your choices (such as language preferences, username, and region).

# **Cookies Usage**

We may use cookies for different purposes, for example:

- to ensure the security and functionality of the Website and Service;
- to prevent fraud and other malicious interventions on the Website and Service;
- to enhance user experience on the Website and Service.
- to recognize your device and save the actions you have previously made;
- for marketing purposes as provided for in the description of the marketing cookies;
- and for other purposes described in this Policy.

## **Legal Bases**

We use cookies under Article 6 of the GDPR based on your consent (Art. 6(1)(a)) or our legitimate interest (Art. 6(1)(f)).

**Necessary cookies are always active.** We collect necessary cookies based on our legitimate interest, namely for such purposes:

- to ensure the security and functionality of the Website and Service;
- to prevent fraud and other malicious interventions on the Website and Service;
- to enhance user experience on the Website and Service.

Preferential cookies are off unless the user has explicitly requested the service, such as changing the language. In this case, they turn on automatically to ensure the user's request.

Other cookies, namely analytical and marketing cookies, are used only based on your consent.
